2019 SWISCC Rallye code proposed changes:

1. 11.4 Novices

CHANGE: “entered more than three (3)”

TO: “entered more than five (5)”

2. 11.3 SOP+ (Seat of the Pants+)

CHANGE TO:

Same as SOP, plus the use of Cruise Control or Average Speed functions

3. 11.2 SOP (Seat of the Pants)

Reads the same except :

DELETE: “ and no more than one”

4. 11.1 Navigational:

ADD: The use of GPS or Any App Program other than time of day or stopwatch apps.

5. Change order of numbers so Novice is 11.1, SOP is 11.2, SOP+ is 11.3 and Navigational is 11.4

6. Eliminate end of year award for overall champion

No other recommended changes to the Rallye Code or Points Rule
